

Greece (Flights within Greece)

[Quarantine](#) **Not Required**

There is currently no quarantine requirement for travelling within Greece.

[COVID-19 Test or Vaccination or Recovery](#) **Required**

Travel within Greece

All passengers, on domestic flights departing from mainland airports to the Greek Islands must meet one of the following conditions:

- have completed at least fourteen (14) days of **vaccination for COVID-19** and present a vaccination certificate, which has been issued through the [official website](#). In the case of foreigners from abroad, have completed at least fourteen days (14) the vaccination for COVID-19 and present a vaccination certificate in English, French, German, Spanish, Italian or Russian, issued by a public authority in accordance with the relevant legislation. The vaccination certificate includes the name of the person, the type of vaccine given and the number of doses. Alternatively, passengers may present, in digital or printed form, the EU DIGITAL COVID-19 CERTIFICATE containing information on the vaccination or the result of the final test (48-hour rapid test or 72-hour PCR) or COVID-19 recovery.
- have a **negative COVID-19 test with a PCR test** performed within the last seventy-two **(72) hours** prior to the scheduled travel time **or with a rapid antigen test** within the last forty-eight **(48) hours** before the scheduled travel time. In the case of foreigners from abroad, they can provide a negative test certificate in English, French, German, Spanish, Italian or Russian.
- have a proof of recovery from COVID-19 either by presenting a COVID-19 recovery certificate issued at least 30 days after having tested positive, the certificate is considered valid for at least 30 days and at most 180 days after the initial positive result; or by presenting a positive COVID-19 Antigen, PCR or RT-PCR test result issued at least 30 days and at most 180 days before arrival. The proof must be either in English, French, German, Spanish, Italian or Russian, properly issued, in accordance with the relevant legislation.

Minors from the age of twelve (12) up to seventeen (17) departing from mainland airports to the Greek Islands are obliged to present a negative self-diagnostic test (self-test), conducted twenty-four (24) hours before the scheduled flight, properly documented.

As of 9th of August

All passengers on domestic flights **departing from any Greek island to mainland airports** must meet one of the aforementioned conditions (vaccine certificate, proof of recovery, negative COVID - 19 test) **OR** present a negative self-diagnostic Test (self-test) conducted up to twenty-four (24) hours before the scheduled flight, confirmed by a relevant self-test

certificate completed and issued from the site <https://self-testing.gov.gr/covid19-self-test-print.pdf> in Greek or English.

Minors below the age of twelve (12) born after 01/07/2009 are exempted from the above obligations.

The negative diagnosis of the control by the method of PCR and rapid test is proved by the demonstration of a relevant certificate in printed or electronic form. If these tests have been carried out abroad and are valid at the time of boarding the aircraft, the relevant certificates are accepted under the same conditions under which they were allowed to enter Greece.

Required Forms or Applications **Not Required**

For travelling within Greece, there is no need for a PLF to be completed.
